6.1 Our Employees

Our employees are our most valuable resource and it is their knowledge and skill that determine the quality of the work that is performed. The Office is organized to allow for the efficient and effective deployment of staff and to support our work.

As of 31 October 2005, our Office had 38 employees, 34 in the head office and 4 in the regional office in Corner Brook. Six employees work in administrative and IT support, while the remaining 32 work directly in audit. Of these 32 audit staff, 24 have professional accounting designations and 6 are in the process of completing their professional accounting program. Our Network Administrator has a CNA designation. We also have 1 employee who is funded through the Employment Equity and Strategic Initiatives Division of the Public Service Secretariat and works in IT support.

The organizational structure of the Office is outlined in Figure 3.


